THESE RATES WERE ALSO DISCUSSED INFIRMALLY WITH BOARD AND ADVISORY COUNCIL MEMBERS AND AGREED UPON FOR CONTRACTORS. ALL SERVICES HAVE BEEN AGREES UPON BASED UPON THE ESTIMATED RATES AND COSTS BY THE CONTRACTORS' SERVICES, OR AS STIPULATED IN GRANTS RECEIVED.
